### Core Function and Objective

- Focuses on public safety and quality of life in neighborhoods
- Collaborates with City's Code Compliance and Engineering Services departments, which share information on issues and public works projects
- Provides a forum for neighborhood collaboration on resolving shared issues through work groups

### Key Projects and/or Accomplishments

- Supported and educated residents on "Hot Spots" projects to improve vehicle, pedestrian, and bicycle safety in the city, and provided comments on neighborhood traffic calming projects
- Provide monthly reports on code violation complaints and resolution by neighborhood, and updates on public works projects such as Hot Spots and Indian Canyon two-way conversion
- Work groups proposed to the City a trash container ordinance change and means of dealing with noise from outside entertainment events and are working on parking issues on residential streets

### Core Function and Objective

From the outset of the PSNIC/ONI discussions, the “environment” was an issue of notable concern. How could the ONI beneficially impact our natural surroundings, thus ensuring an ever-improving quality of life?

The mission of this committee is to promote conservation through modeled behavior and education. We advocate for changes both behavioral and governmental through involvement in the obvious and most effective methods available to protect and improve our environment.

- To identify and promote sensitive solutions to ecological problems
- To promote all efforts to reduce the carbon footprint left by our residents
- To educate the public in ways individuals can make a difference
- To promote “home ecology” and marketing of affordable products for same

### Key Projects and/or Accomplishments

Successful campaigns thus far have included (often in collaboration with the Sustainability Commission):

- Replacement of “lush” gardens with desert landscaping
- Adoption of California’s stricter tobacco sales standards to minors by the City
- Movement to replace fuel-driven leaf blowers with alternatives
- Education of residents about drought-resistant vegetation (vs. ornamental)
- Education of residents about food-producing vegetation (vs. ornamental)
- Created, through the Sustainability Office, rebate/buy-back programs for low flow toilets, lawns, food producing trees
- Research and advocacy for bike lanes and downtown bike racks
- Research and advocacy for ban on single-use plastic bags

*Future goals include:*

- Creating a sorting and re-use program for materials reclaimed from demolition sites
- The adoption of height limits for “green walls”

### Committee Composition and Function

The Events Committee is made up largely of the chairs of the many sub-committees set up for each specific event where ONE-PS is involved. Other interested persons are also on the committee.

### Key Projects and/or Accomplishments

For 2018, our accomplishments include the following:

- We participated in the Black History Parade for the second year. We also had the ONE-PS booth at the Black History Town Fair.
- We hosted the 11th annual ONE-PS Picnic and Community Expo at Ruth Hardy Park with over 1000 attending and over 60 community booths were part of the fun day. Free food and a dog contest were included.
- ONE-PS was in the PRIDE Parade and sponsored a booth over the two-day event.
- We had an entry in the annual Veteran's Day Parade down Palm Canyon Drive.
- We participated in the National Night Out event hosted by the Palm Springs Police Department.
- We hosted two forums for the public; an issues forum on vacation rentals and a candidate forum for candidates for the Desert Water Agency Board.
- We organized the annual Home Tour of Mid-Century Modern Homes during Modernism Preview week in October. This was our main fund raiser for ONE-PS this year.
- Our first event Volunteer Appreciation Event was held to honor our many volunteers. It was coupled with the presentation of the ONE-PS Chairperson's plaque that now hangs at City Hall.
- We organized nine neighborhoods to be "balloon wranglers" to handle the large helium-filled balloons for the Festival of Lights parade.

We met and exceeded our goals of outreach, involvement and "fun" for 2019! Special thanks to the event chairs and the over 200 volunteers.

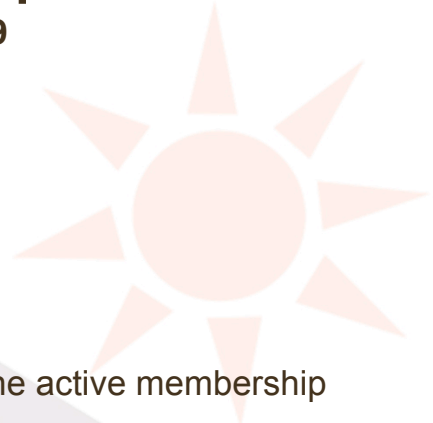
