October 31, 2022, marked the end of the fourth month of the ONE-PS 2022-23 fiscal year. The attached reports are for that period.

The first report in the attachment is a Statement of Financial Position (Balance Sheet) as of the end of business on October 31, 2022. The balance in our bank account at Wells Fargo Bank at that time was \$55,844.79. The bank balance, per our books, at that time was \$54,844.79 with a \$1,000.00 check to the Cultural Center still outstanding.

The second report is a Statement of Activity (income Statement) for the month of October 2022. During the month, we received \$2,548.00 as an additional share of the Modernism Home Tour ticket sales!! We had no other accounts receivable at the time, but we did owe \$2,258.87 for Home Tour and Pride Week expenses, which have since been paid in full. During the month, we had expenses of \$2,573.87. \$315.00 was for ASL support for the October monthly membership meeting, \$1.692.37 for Modernism Home Tour expenses, and \$566.50 for Pride Week expenses. We had a total decrease in our bank account of \$25.87 for the month.

The third report is a Statement of Activity (Income Statement) for the first four months of the 2022-23 fiscal year. For that period, we had \$17,472.00 in revenues and total expenditures of \$6,716.75, resulting in an increase in our bank account for the period of \$10, 755.25.

The fourth report is a copy of our bank statement at Wells Fargo as of the end of October 31, 2022.
